Regular Meeting February 21, 2024

MINUTES

A. Call to Order

The Regular Meeting of the Wayne County Regional Educational Service Agency Board of Education was called to order by Vice President James Petrie on February 21, 2024 at 8:29 a.m.

C. Pledge of Allegiance

D. Approval of Agenda

Member Blackmon, supported by Member Beri, moved to approve the agenda as presented. On voice vote, the motion carried 4-0.

G. President's Remark and Board Comments

Member Blackmon provided updates from the Metropolitan Affairs Coalition (MAC) meeting held February 20, 2024, including Civility Day where there will be discussion with college students regarding civil engagement.

Member Blackmon acknowledged Black History Month and the RESA Social Studies Department for providing resources for districts and staff. Member Blackmon also acknowledged longtime River Rouge resident, Ms. Claudia Williams, who was honored by the community for celebrating her 109th birthday on February 7.

Member Petrie shared the following information highlighted during the National School Board Association's Equity Symposium and Advocacy Institute in Washington D.C. in January.

- Temple Grandin, a prominent proponent of the humane treatment of livestock for slaughter and the author of more than 60 scientific papers on animal behavior. Grandin is also an autism spokesperson.
- The HistoryMakers, a nonprofit organization that preserves and shares the stories of African Americans across various fields and disciplines.
- Mississippi "miracle" Mississippi's rise from having some of the nation's lowest-performing literacy scores to its most improved. The "miracle" was a long term process, which required many moving parts, new laws and fresh thinking.

Member Petrie also thanked Mike Latvis for his efforts organizing the legislative meetings while in Washington D.C. Wayne County School Board Members were able to meet with Congresswoman Rashida Tlaib, Representative Debbie Dingell and Congresswoman Lisa McClain.

Board members shared their condolences to RESA Board President Lynda Jackson for her recent loss and spoke about the impact Chaz Jackson had on the staff at Burger Baylor and the many memories shared about Chaz throughout the years.

The Board also acknowledged and welcomed former State Superintendent and former Wayne RESA Superintendent, Michael Flanagan, and thanked him for attending the meeting.

Vice President Petrie shared highlights from Wayne County Schools:

- Grosse Pointe Congratulations to the Grosse Pointe Public School System which had 3 elementary schools, Richard, Defer, and Maire ranked as three of the top ranked elementary schools in Michigan per Niche.
- Hamtramck Congratulations to Noah G. and Priya R. from Hamtramck Public Schools for being selected to serve on the Wayne County Commission Youth Council.
- Livonia Congratulations to Eric Bottorff, Livonia Public Schools Music Content Area Leader and Music Teacher at Randolph Elementary who has been honored as the 2023 Michigan Music Teacher of the Year by the Michigan Music Education Association (MMEA).
- **Plymouth-Canton** Congratulations to Plymouth-Canton Salem HS students, Mahdi M., 1st place winner and Jacob D., 3rd place winner in the Suburban Collection "Focus on the Road" public service announcement video contest which encourages young drivers to practice safe driving and "Focus on the Road."
- Woodhaven-Brownstown Congratulations to Woodhaven-Brownstown Wegienka Elementary School students Carmen R., Nazareth L., Blake M, Evangeline B, and Avery H. for their artwork that is being showcased at Washtenaw Community College as part of the Michigan Art Education Association exhibit.
- Wyandotte Congratulations to Wyandotte Roosevelt High School Social Studies teacher, Jason Krajewski on being named the Veterans of Foreign Wars Department of Michigan High School Teacher of The Year.
- Northville Congratulations to Northville High School Alumni, Jake Moody who now owns the longest field goal in Super Bowl history at 55 yards. Although the San Franscico 49ers came up short, Jake made Northville and Wayne County proud.

I. Special Presentations

- 1. Support to Partnership Districts Dr. Markita Hall, Executive Director of Educational Services; Russell Robinson and Natalie Turner, Education Improvement Consultants, provided an update on Wayne County Partnership Districts including Wayne RESA assurances and goals overview. Support provided to River Rouge School District and Barack Obama Leadership Academy were highlighted by the consultants, and Partnership District testimonials were provided to the Board.
- 2. Safe & Health Schools: School Safety and Mental Health Supports Terri Czerwinski, Director of Safe & Health Schools; Mona Berry, School Health/Social Work Consultant; Sharon Black-Johnson and Maribeth Lyons, School Outreach Nurses; and Dr. Cynthia Cook, School Health Consultant highlighted Wayne RESA's school safety and mental health supports including the Whole Child Model & Multi-Tiered Systems of Support (MTSS), School Nursing Programs, Social Work Programs, School Safety Initiatives and additional collaborative efforts.

J. Superintendent's Report

Executive Director of Legislative Affairs Mike Latvis

Mr. Latvis shared the following legislative updates:

- The Dyslexia bills are a priority. Concerns have been raised regarding this being an unfunded mandate and literacy coaches needed to support these bills in the midst of the educator shortage, which could result in districts being out of compliance with statute. The bills passed out of the Senate on February 20, 2024 and the House is expected to review the package in April. Meetings will continue with the bill sponsor.
- A new package of updated school safety bills may get a hearing in the House.
 - o The House will be hosting an in district hearing in Macomb in mid-March regarding the shortage of school safety and mental health staff.
- The Governor's Budget recommendations include a 2.5% increase in per pupil funding. The proposal spreads that 2.5% increase to Special Education, English Language Learners, rural/isolated districts, at-risk students, ISDs, CTE and the Great Start Readiness Program.
- Wayne County had an increased presence at the National School Board Association's Advocacy Institute. Wayne County had eleven attendees representing Dearborn Heights #7, Harper Woods, South Redford, Westwood and Wayne RESA.
- The Wayne County Association of School Boards (WCASB) met on February 15, 2024 and there was increased participation. The agenda included legislative updates and a presentation on the Wayne County Regional Enhancement Millage.

Deputy Superintendent of Administrative Services, Kelly Bohl

Ms. Bohl shared the following updates:

- Details were provided for three action items on the February meeting agenda:
 - o In response to a November 20, 2023 Miller Johnson School Policy Service update, recommended changes to policy and administrative regulations will be presented to the Board for first reading.
 - Wayne RESA has been asked by the Michigan Department of Lifelong Education, Advancement, and Potential (MiLEAP) for additional leadership and support of their initiative through a release of our current Executive Director of

- Early Childhood Services, Dr. Sophia Lafayette-Lause, through an Educator on Loan agreement.
- O The scope of responsibilities for Elizabeth Grace, current Manager of Early Childhood, has continued to increase and expand. To reflect the additional responsibilities Ms. Grace has assumed, it is recommended that Ms. Grace be reclassified from Manager to Director.

 Additionally, based on the request from MiLEAP and pending approval by the Wayne RESA Board, a restructuring of the Wayne RESA Early Childhood Education Leadership Team is merited to continue to lead the work in increasing access to early childhood education; therefore, authorization to appoint Elizabeth Grace as Interim Executive Director of Early Childhood Grace during the Educator on Loan Agreement is being proposed.
- RESA closed on the Annex property February 15 2024. The Operations Team is working on phased planning which will include updating HVAC controls, required repairs to the building's roof soffit and fascia, and the demolition of the outer buildings on the property that are in great disrepair.

Assistant Superintendent of Financial Services, Drew McMechan

Mr. McMechan shared details regarding the 2023-24 Budget Amendments being presented for consideration and approval by the Board during the February meeting. Significant changes in the budgets for the General, Enhancement, Act 18, Special Education Operating, Medicaid, Cooperative, and Capital Projects funds were discussed.

Superintendent Dr. Daveda Colbert

Dr. Daveda Colbert shared:

- During the month of February, RESA celebrates Black History Month or African
 American History Month and lifts the deep cultural, academic, and societal contributions
 that the Black/African American community has paved nationwide. Information and
 resources were shared with staff in the February Issue of the Wayne RESA Monthly
 Newsletter including a link to the National Museum of African American History and
 Culture initiatives.
- Thanks to Senior Executive Director of Communications, Public Relations, and Marketing, Dana Chicklas, RESA Communications has ramped up with internal and external stakeholders.
- New Superintendent of Grosse Pointe Public School System, Dr. Andrea Tuttle, began on February 5, 2024. She has been doing a great job familiarizing herself with the district, community, and the county. Interim Superintendent, Dr. Michael Williamson began in Hamtramck on February 9, 2024. RESA will continue to provide support to both districts during these transitions.
- Dr. Colbert attended and presented with colleagues from across the country at the AASA National Conference on Education (held February 15 17, 2024), as they strategized about all things public education. Two of the areas of focus were: 1) identifying next steps as it relates to pushing Congress to act as it relates to fully funding IDEA 2) and ensuring that Title funding is not decreased in any way moving forward.
 - o Dr. Colbert shared that it was an honor to participate in a panel discussion along with four other superintendents from across the country about the mental health needs, challenges, and solutions, where some of Wayne County's best work was

- shared. The presentation was supported by information and data provided by the Safe and Healthy Schools Team. Director Terri Czerwinski provided a wealth of information that was shared during panel discussion responses. Superintendents from Dearborn, Flat Rock, Gibraltar, Huron, and Plymouth-Canton were present during the panel discussion and were able to attest to the work being done in Wayne County.
- O Superintendents from Flat Rock, Gibraltar and Huron also facilitated a roundtable and spoke to their collaboration, as well as, the collaboration that is encouraged throughout the county, and the supports, partnership, and collaboration with RESA. They shared their appreciation for Dr. Colbert and the RESA Team. Superintendents from Dearborn and Plymouth-Canton were also present and spoke to how Wayne County School Leaders work together and support each other.
 - "If your actions inspire others to dream more, do more and become more, then you are a leader." John Quincy Adams
 This quote was shared by Dr. Colbert in correlation with RESA's vision: Leading Learning for All, which became RESA's driving force more than 20 years ago under the leadership of the Honorable Michael Flanagan, former Farmington and RESA Superintendent, and Superintendent of Public Instruction for the State of Michigan (Michigan Department of Education) who was in attendance at the February 2024 RESA board meeting. Former Superintendent Flanaghan shared a few words of wisdom and memories from his time as the leader of the organization.
- Kudos to RESA's Safe and Healthy Schools and the Special Education departments whose work was highlighted nationally during the AASA conference.
- As it relates to the School Finance Research Foundation and 11Y Infrastructure Study, the building assessments have begun. More than 95% of the districts in Michigan signed up to participate in the Infrastructure Study and more than 74% of the districts in Michigan signed up to participate in the Energy Efficiency Study.
- The RESA All Staff Meeting will be held on Friday, March 1 at 8:30 a.m. Lisa Kaiser and Dr. Terrance Scott will lead the climate and culture continuation of learning. There will also be department updates and a teambuilding activity with the Digital Business Cards.
- Thanks to the RESA Technology and Building Services Teams for ensuring that RESA's technology and hospitality are first class at all times.
- During the 2024 National School Board Association (NSBA) Advocacy Institute, Wayne County attendees advocated for:
 - Support of free/reduced lunch on a federal level (Michigan is one of 8 states with universal meals);
 - o Increase of Title funding or at the bare minimum that the funding stays the same; and
 - o The IDEA promise/commitment of 40%. There is also a request for a congressional hearing on full funding of IDEA.

RESA will continue to advocate to the highest level for full funding of IDEA, a continuation of Title Funding at the current allocation, and School Safety and Mental Health.

- Two action items on the RESA Board of Education February agenda reflect the great things happening at Wayne RESA. Wayne RESA is leading the expansion of early childhood services, both within Wayne County and across the State and has been asked by the Michigan Department of Lifelong Education, Advancement, and Potential (MiLEAP) for additional leadership and support of their initiative through an Educator on Loan agreement. The agreement requests Dr. Sophia Lafayette-Lause, Executive Director of Early Childhood at RESA, to serve as the as the Interim Project Management Office (PMO) Director MiLEAP. To meet this request and continue to lead the work in increasing access to early childhood education, a restructuring of the Wayne RESA Early Childhood Education Leadership Team will be merited. The second request to the Board for approval is to appoint Elizabeth Grace, Manager of Early Childhood, to the position of Director of Early Childhood for the expanded scope of work she has been doing and upon the execution of the Educator on Loan agreement, she will be reclassified as the Interim Executive Director of Early Childhood.
 - o The work of RESA Leadership was acknowledged starting with Dr. Lafayette-Lause and Ms. Grace for their work in Early Childhood, which is supported by the entire team of Early Childhood Consultants and support staff, and extending to Dana Chicklas for her GSRP marketing and communications work, Dr. Jennifer Taiariol for Early Intervention Services, Mike Latvis for his legislative work, Kelly Bohl and Beth Gonzalez for their work on the memorandum of understanding and Drew McMechan for his flexibility and expertise as these changes impact all departments and the financial commitment of the organization. Kudos to the great work of the team.
