MINUTES

A. Call to Order

The Regular Meeting of the Wayne County Regional Educational Service Agency Board of Education was called to order immediately following the Organizational Meeting President Jackson on July 19, 2023 at 9:00 a.m.

G. President's Remarks and Board Comments

Member Petrie thanked Past Board President Beri for his leadership over the past year noting that Member Beri has held the position many times throughout his time on the Wayne RESA Board of Education.

Member Blackmon echoed Member Petrie's remarks and expressed her appreciation for Past President Beri's relaxed and inviting manner and his great relationship with colleagues on the board.

Member Petrie shared that the board is in the middle of their annual two day board retreat. He thanked Dr. Colbert for her thoroughness and thoughtfulness with planning the retreat.

Member Blackmon added that Dr. Colbert, Superintendent, has been very deliberate in making sure that RESA has all of the resources needed at a reasonable cost and without sacrificing the quality of the work.

Member Beri thanked the Wayne RESA Board of Education, Superintendent, Dr. Colbert, and the Wayne RESA Administration for their support and staying the course with educating students in Wayne County.

Member Blackmon thanked Kate de Fuccio and Wayne RESA for their involvement with the NAACP Essay Contest. The efforts are much appreciated. Also, thanks to Wayne RESA for always submitting a great ad for the souvenir journal issued during the Detroit Chapter of the NAACP's Annual Fight for Freedom Dinner each year.

Member Blackmon also paid tribute to former Detroit councilwoman and civil rights icon JoAnn Watson and her significant contributions to the City of Detroit.

President Jackson shared the following highlights from Wayne County Schools –

- Allen Park Congratulations to Allen Park High School's Abby Russell who is a state champion in the discus, as well as, a national competition 3rd place winner.
- **Dearborn** Congratulations to Dearborn High Class of 1997 graduate Michael Mosallam who recently won a Tony Award as one of the producers of "Parade," which won for Best Revival of a Musical.
- Ecorse Kudos to Ecorse High School cosmetology students who were hard at work celebrating working dads during the Father's Day of Pampering event. The Ecorse student salon will re-open in the Fall.

 President Jackson shared that she had the opportunity to visit the salon and shared that it was
- Grosse Pointe Congratulations to Grosse Pointe South athletes Olivia Bachert, Carly Brown, Ava Sjogren, Ryleigh O'Donoghue, and Cassie Summerfield, who won the Women's Youth 4+ A Final National Rowing Championship in Sarasota, Florida.
- Northville Congratulations to the Northville High School's 3,200-meter relay team: Brendan Herger, David Whitaker, Brock Malaikal and Brandon Latta for posting the fastest time in the country in their event and earning back-to-back MHSAA Division 1 state titles. Congratulations to Northville for also winning their first state boys golf title. The Mustangs are Division 1 golf state champions.
- Plymouth-Canton The Plymouth-Canton Education Park Choir recently participated in the Music in the Parks Festival at Cedar Point and took home eight first place awards as well as three individual awards (soloist, student conductor, and best conductor). All of the Plymouth-Canton choirs swept their category. P-CEP Choirs are directed by teacher Jennifer Neumann. Also, Congratulations to Canton sophomore Quincy Isaac who won the state title in the long jump with a distance of 22 feet, 11 inches, beating the runner-up by a full 4 inches.
- Wayne-Westland Congratulations to Wayne-Westland Superintendent Dr. John Dignan, who was honored with a Distinguished Service Award at The Engineering Society of Detroit Annual Dinner.

- Woodhaven-Brownstown Woodhaven-Brownstown School District has partnered with Dolly Parton's Imagination Library to give the gift of books and instill a love of reading to children ages birth to five years old. Children from birth to five who live in the Woodhaven-Brownstown School District are eligible for free monthly books through this partnership.
- H. Communications The board acknowledged receipt of information that was hand delivered to the Board Office by John Lauve on July 18, 2023. Mr. Lauve provided each board member with a copy of an Estimated Tax Capture Revenue form (highlighted by Mr. Lauve), a handwritten document dated July 17, 2023 which provides examples of Detroit/Ilitch projects, and a copy of the Detroit Metro Times, Volume 34, Issue 30, dated May 7-13, 2014.

I. Superintendent's Report

Executive Director of Legislative Affairs Mike Latvis

Mr. Latvis shared the following legislative updates:

- The FY24 School Aid Budget will include
 - o Foundation allotment increases by \$458 per pupil, taking it from \$9,150 to \$9,608
 - o \$71m for declining enrollment
 - o \$310m to reduce the amount of a special education pupil's foundation allowance that counts toward special education costs to 0%
 - o \$204.5m increase for at-risk
 - o \$160m for universal school meals
 - \$125m to the School Transportation Fund, which uses the SFRC's recommended formula
 - o \$90.9m increase for GSRP, which not only increases the per-pupil allocation to align with the foundation allotment but provides \$11,530 per pupil if GSRP programs transition from 4-days to 5-days.
 - Some Wayne County Districts will receive additional funds ranging from \$250k - \$11 million.
- Prohibitive Subjects/Public Employment Relations Act (PERA) Bills were passed and are expected to be signed by the Governor. Dr. Colbert wrote an op-ed that was published in the Free Press calling on the Governor to veto the bills and submitted a veto request letter directly to the Governor which mirrored the op-ed.
- Another policy piece expected out of the House is HB 4752 that proposes changes to the ORS system to bring back retirees. The goal is to remove the salary cap during the 9 month waiting period and give districts the flexibility that they need.

Deputy Superintendent of Educational Services, Beth Gonzalez

Ms. Gonzalez shared the following update:

- The Talent Together program has secured funding and the first cohort of applicants have been notified. Wayne County has 25 certified candidates seeking additional endorsements and 155 candidates seeking their first certification. These candidates represent 37 districts/PSAs and there is already an open interest form for Cohort 2 in 2024-25. In addition to the Para-to-Teacher program, Talent Together will have a large impact on the teacher shortage in Wayne County.
- The Wayne RESA Instructional Technology Team has been working on being the lead ISD in the state in regard to Artificial Intelligence in education. A steering committee was established made up of members of the instructional technology team, as well as other teams throughout RESA, and members from local districts and public school academies. The committee is developing a

guidance document to help districts support students in the classroom, develop district level policy and provide questions to consider as this technology continues to evolve. RESA is also hosting a one day professional learning event: AI & The Future of Education with Matt Miller on August 16, 2023. There is no doubt that Artificial Intelligence (AI) will have lasting impacts teaching and learning. This session aims to prepare leaders and educators for this shift.

Deputy Superintendent of Administrative Services, Kelly Bohl

Ms. Bohl shared summaries of the action items being presented to the Board for approval:

- Amendment to the lease agreement with Southgate community School District Beacon Day Treatment Program provides for additional time if needed.
- The proposed Wayne RESA compensation adjustments impact everyone within the organization and will assist with recruitment and retention. It allows RESA to be more competitive in the job market and retain the high quality talent that has been brought in.
- A significant advantage of being part of the policy service is that as federal and state legislation changes, policies are updated. A policy service update will be presented for first reading.

Superintendent Dr. Daveda Colbert

Dr. Daveda Colbert shared:

- School year 2023-2024 has been filled with exciting activities and events that have been
 impactful since July 1, 2023. There is great work happening throughout Wayne County
 and we look forward to the outcomes throughout the year.
- RESA successfully closed out school year 2022-2023 and a Services Summary for the year was provided to the Board during their Annual Retreat. Thanks to the entire RESA Team for data captured from different departments and systems throughout the organization. Kudos to Deputy Superintendents, Kelly Bohl and Beth Gonzalez, and Senior Executive Director of Information Technology Kurt Rheaume for compiling the data, and thanks to Dana Chicklas, Kate de Fuccio, and members of the communications team for the formatting and design, as well as, making the information available on the RESA website. The document speaks to the great work happening throughout Wayne County which aligns with our vision, mission, and goals.
- RESA is very concerned about the most recent legislation changes to the Public Employment Relations Act (PERA) which will impact students, especially the most vulnerable student populations including multilingual learners, economically disadvantaged students, students with disabilities, black and brown children and children in need of additional assistance as they continue to recover from the pandemic. RESA will continue to work with legislators, school leaders, and unions alike in hopes of minimizing the unintended consequences that could harm students. RESA will watch this matter closely and continue to elevate the concerns that play out in districts over the next several years.
- Great job Mike Latvis and the Wayne RESA Team! RESA had amazing opportunities to work with legislators around this year's budget, ensuring that it is closely aligned with the

School Finance Research Collaborative (SFRC) outcomes from 2018 and updated in 2021. RESA is excited about the continued press to ensure that every student gets an education that speaks to equity and excellence. Unique budget pieces include:

- o School Safety and Mental Health Commission, which was general funded in last year's budget and was placed in the Michigan Department of Education, continues to be funded, with the fiduciary responsibility transitioning to Wayne RESA.
- o RESA has also become the fiduciary for others including Junior Achievement, Brilliant Detroit, and City Year.
- RESA is the leader in the work around Artificial Intelligence (AI)I in education. On August 16, 2023, Wayne RESA is offering professional learning on AI & The Future of Education with Matt Miller. There is no doubt that Artificial Intelligence (AI) will have lasting impacts on teaching and learning. This session aims to prepare leaders and educators for this shift. There will also be a presentation to the RESA Board of Education related to AI during the 2023-2024 school year.
- RESA is also excited about serving as one of the leading ISDs in the Talent Together
 initiative which aligns with one of the organization's goals that seeks solutions for the
 teacher shortage and making sure Wayne County has a major impact on teacher
 recruitment in support of a diverse talented workforce.
- RESA serves as one of the key leads of the School Finance Research Foundation (SFRF) Infrastructure Study, which is part of the School Finance Research Collaborative (SFRC). The purpose of the study is to assess the health, safety, and wellness of each of Michigan's school buildings. Facilities are important, and school buildings should look like educational institutions that support student success, and this should not be predicated on zip code and tax structure. Facility assessments will be completed on each K-12 Intermediate School District (ISD) and Local Education Agency (LEA) building with students throughout the State. The data captured will be used to inform the legislature of funding needs to support excellence in education throughout the state. Plante Moran partnered with Barton Malow and was awarded the contract by the School Finance Research Foundation (SFRF), a 12 member board of ISD Superintendents to which Dr. Colbert serves as Vice President, who will oversee the project. A survey will be forwarded to districts next week with walkthroughs beginning September 2023 through October 2024.
- Congratulations to the School District of the City of Wyandotte's new superintendent, Dr. James Anderson effective July 1, 2023.
- Dearborn Heights School District No. 7 has hired an Assistant Superintendent, Mark Kleinhans, who will serve as Acting Superintendent for the district.
- Save the Dates -
 - In response to requests throughout the County, the following affinity groups will be formed to support diverse talent in executive leadership in Wayne County. Kickoff meetings will be held at Wayne RESA in September.

- RESA is excited about Michigan being the 7th state in the country with universal meals which offers free breakfast and lunch to all students.
