A. Call to Order

G. President's Remarks and Board Comments

Member Funderburg shared that the Wayne County Association of School Boards Executive Board Meeting is August 17, 2023.

Member Blackmon shared that the Metropolitan Affairs Coalition (MAC) meeting was held August 15 and there was a presentation on economic issues for the region. More information is available MAC's website.

Secretary Mary Blackmon shared the following highlights from Wayne County Schools -

- **Detroit** DPSCD received \$4.5 million to launch 12 Health Hubs at neighborhood high schools. Families will have access to comprehensive resources at community high schools starting with five Health hubs opening this fall. Thanks were extended to the Ballmer Group, the W.K. Kellogg Foundation, The Kresge Foundation, and The Children's Foundation for this significant commitment.
- Grosse Pointe Grosse Pointe has a World Rowing Champion! Congratulations to Grosse Pointe South senior Carly Brown for all of her hard work and dedication as a member of the USA women's 4 who won the gold.
- Livonia & Plymouth The Livonia Churchill and Plymouth football teams hosted the 9th Annual Sunshine's Skills and Drills Clinic for children with special needs on Friday, July 28. Kudos to the student athletes and coaches!
- Mel-Nap A statewide educational association is honoring local educator Kerry Giuliano with its 2023 Making IT Happen award that honors outstanding educators who demonstrate extraordinary commitment, leadership, courage, and persistence in improving digital learning opportunities for students. Guiliano serves as an instructional technology coach for Melvindale-Northern Allen Park Public Schools where she created and implemented the Mel-NAP Virtual Academy.
- Northville The Niche Best Schools in Michigan rankings celebrate the great things at Northville Public Schools. Northville was ranked #1 for Best Places to Teach and #3 for Best School District, with a few additional top 10 accolades.
- Wayne-Westland Congratulations to Janayah Watts, a Wayne Memorial High School student for being selected to serve on the 2023-2024 Michigan Department of Education (MDE) Student Advisory Council. The council will provide perspective and feedback on new and ongoing MDE initiatives and efforts. The group will also extend the work of last year's committee to finalize a guidance document for school district leaders that provide recommendations, examples of best practices, and other materials to support the creation of safe spaces in schools to discuss race and racism that will be shared with school districts across the state.

H. Communications – None.

I. Superintendent's Report

Executive Director of Legislative Affairs Mike Latvis

Mr. Latvis shared the following legislative updates:

- The FY24 School Aid Budget was signed by the Governor on July 20, 2023. Legislators are celebrating record education funding. There is concern from Wayne County Superintendents that the celebration creates a false narrative that schools are fully funded when districts are dealing with operating deficits. The updated School Finance Research Coalition study reported that the base per-pupil cost to educate a Michigan student should be \$10,421. The current per-pupil allotment is \$9,608.
- A small supplemental is expected in September-October. Wayne RESA and Wayne County Schools have requested funds to be included in the supplemental.
- Prohibitive Subjects/Public Employment Relations Act (PERA) Bills The Governor signed the PERA package (4354, 4820, 4044, and 4233) the week of August 7. There was a technical legislative process issue that prevented House Bill 4356 (3rd Party contracting) from being signed into law. The intent is that this will be fixed in September.
- Policies currently being discussed in the Senate include Retirement, Work Keys, Healthcare (80/20 hard cap), Teacher Evaluations. The House is discussing Charter School Transparency bills.

Deputy Superintendent of Educational Services, Beth Gonzalez

Ms. Gonzalez shared the following updates:

- In 2022, the Revised School Code was revised to require that all students, starting with those entering eighth grade in 2023 (current year), complete "a ½ credit course in personal finance that aligns with the subject area content expectations developed by the department and approved by the state board..." RESA will support districts with whatever avenue they chose for implementation. A summary of the most common implementations was shared with the Board.
 - Member Beri asked about the community service graduation requirement. It was shared that the community service credit is no longer mandatory but is still optional in some districts.
- The professional learning offering of AI & The Future of Education with Matt Miller is August 16, 2023 at WCCCD Ted Scott Campus. An update from the summit will be shared with the Board. RESA has also developed an Artificial Intelligence (AI) Guidance Document that will be shared with school leaders and the Board.

Deputy Superintendent of Administrative Services, Kelly Bohl

Ms. Bohl shared the following update and summary of the action item being presented to the Board for approval:

- The MAC Healthcare Task Force meeting was held August 9. There was a presentation by Leslie Meyer, Vice President of Patient Experience and Health Equity for Corewell Health, sharing that when Beaumont and Spectrum merged to create Corewell Health they were able to immediately benefit from the work Spectrum had done to improve equitable access to healthcare which created a big infusion of resources and support. There was also discussion about creating and continuing to embed resources and health clinics in schools.
- Last month the Board was asked to consider updates to the RESA Board Policies and Administrative Regulations recommended by Miller Johnson's Policy Service. This month those updates are being presented for adoption. The changes either reflect updates in the law and changes to definitions or updates based on experiences from Miller Johnson attorneys and work done with their school based clients.

Assistant Superintendent of Financial Services, Drew McMechan

Mr. McMechan shared the following updates:

- The RESA transportation team has been providing bus driver training all summer
 at the Education Center. Great job to Kelli Schultz and the Transportation Team
 for being one of 17 trainers in the State of Michigan. RESA trains all bus drivers
 in Wayne County from entry level to recertification, and RESA also provides
 training to many bus drivers across the state.
- RESA's onsite audit will begin on September 5. The team from Plante Moran is expected to be onsite for approximately 2 weeks.

Superintendent Dr. Daveda Colbert

Dr. Daveda Colbert shared:

• We are aggressively moving through the second month of the 2023-2024 school year, and I would like to take the time to give a "shout out" to the Wayne RESA Team Members

from each department throughout the organization! We are leading and supporting in a variety of ways, as our partnerships continue to get stronger with each of our constituents. RESA is looking forward to a safe, healthy, and impactful school year for each of our districts throughout the county. There are a lot of exciting things happening and it speaks volumes when other ISD leaders are calling from across the state inquiring about the guidance documents, trainings, presentations, coordination of service, and leadership from Wayne RESA. The way in which we support our constituents is not going unnoticed. We must continue to partner and support at the highest level, to ensure each LEA and PSA provides the best service and support to their students, families, and staff.

- O Thanks to the RESA Building Services Team led by Rob McCoy and Robert Burke for what they are doing to continue to elevate a positive climate and culture within the organization. Their contributions are more than aesthetics. The attention to detail and the signs of care, concern, and respect for each employee continues to make us who we are.
- Kudos to the RESA Finance Team for continuing to find ways to use the new accounting system and transitioning updated versions of documents that align with board requests.
- RESA Cabinet members continue to meet with colleagues in local districts this summer. Meetings will continue through the second week of September.
- Schools have begun to have their kickoff/welcome back meetings for staff and open houses/orientations for students and families. Students are returning to school the week prior to Labor Day and/or the day after Labor Day. We wish each of the 260,000 plus students and their families and the educators that they are entrusted to throughout the county an outstanding school year.
- Wayne RESA is committed to being accredited and received a letter and certificate from Cognia that extends RESA's accreditation until June 2025. The review team was aware of the change in leadership and recognized that the health of the organization remains exceptional. The review team was able to review all that we did during COVID and have continued to do over the past year. We have remained a highly engaging, effective and efficient organization. The RESA Team has begun to prepare for a future review, which we know will take place prior to the June 2025 accreditation expiration date.
- The Infrastructure Study is underway. Thanks to Mike Latvis who continues to support the School Finance Research Foundation (SFRF) along with colleagues from other counties.

The SFRF has partnered with Plante Moran and Barton Malow to lead the efforts. A fact sheet and survey has been forwarded to districts and ISDs.

- Information regarding the Infrastructure Study will be presented during the next Wayne County Association of School Boards meeting.
- Steven Ezikian, retired Wayne RESA Deputy Superintendent, has been hired as the Executive Director by the SFRF.
- Dr. Jennifer Taiariol, Assistant Superintendent of Special Education and Early
 Intervention Services has been working in her role for a little over a month and has
 already had a huge impact on improving the Juvenile Detention Facility enrollment and
 exit process, the completion and issuance of the RESA General Accountability and

- Supervision document, and Act 18 Discretionary Funds that was well received by superintendents after the announcement during their subcommittee meeting. Great things continue to happen in the Special Education and Early Intervention Services Department and RESA is honored to have Dr. Taiariol as part of the team!
- On Monday, August 14, 2023, Dr. Colbert attended the Allen Park Board of Education meeting along with Dr. Sophia Lafayette-Lause, Executive Director and Elizabeth Grace, Manager of the Early Childhood Department. Elizabeth Grace was masterful in the way she laid out early childhood and the opportunities around the Great Start Readiness Program (GSRP), research based preschool programming (tuition based), and early childhood in general. Dr. Lafayette-Lause answered every question in great detail with added support from Dr. Colbert. Allen Park Superintendent Mike Darga and Assistant Superintendent Dr. John Tafelski personally thanked the RESA team for their attendance and presentation, and the Allen Park Board of Education thanked the RESA team publicly. Kudos to Dr. Lafayette-Lause and Ms. Grace and the Early Childhood Team for their great work. Wayne County serves as a leader in the GSRP space, as we continue to move towards universal pre-K throughout the state.
- RESA continues to push the federal government to respond to the promise of full funding for IDEA at 40%, as the current funding is under 16%. As we near 50 years of not fulfilling the promise, it is imperative that we keep putting pressure on our elected officials at the federal level, in hopes of getting the commitment fulfilled. The Board of Education will continue to hear more about the efforts and advocacy as strategy work continues with K12 Alliance and Congresswoman Haley Stevens and her team.
- It was announced that Cynthia Nickel, Assistant Superintendent at Taylor School District has been named Acting Superintendent until Michael Wegher takes over as Interim Superintendent on August 21. Thanks to former Taylor School District Superintendent Griff Mills for his service and leadership.
- Conversation continues around RESA purchasing the Annex for current and future endeavors. A proposal will be submitted for consideration of financial support.
 Additional dialogue regarding the timeline for purchase will take place, as we continue to seek funding support.
