G. President's Remark and Board Comments

Member Blackmon shared that she had the opportunity to attend the NAACP National Convention in Las Vegas in July where President Biden brought remarks to a very enthusiastic crowd.

Member Blackmon also shared that she was honored to receive the Michigan Association of School Boards (MASB) President's Award and how happy she is to be among the elite in state to have received this prestigious award, including RESA's Immediate Past President Lynda Jackson.

Member Blackmon thanked the RESA Technology staff and Dr. Colbert for their efforts in ensuring she was able to connect to the July board meetings and retreat virtually.

President Petrie expressed his appreciation for the wonderful sessions during the Annual Wayne RESA Board Retreat held in July. President Petrie thanked Superintendent Colbert and Executive Assistant to the Superintendent and Board, Tiesha Hakim, and all others who contributed to the work to make the two day retreat a success.

President Petrie shared highlights of the items presented to the board during the retreat including:

- Nineteen events held during school year 2023-24 to improve climate and culture throughout the organization.
- Eight health and safety updates made throughout RESA campuses and buildings.

Member Funderburg added that day two of the board retreat included Superintendent Evaluation training facilitated by Dr. Rod Green, MASB Consultant, who provided updates and a refresh on the MASB evaluation tool and expectations.

President Petrie announced that Team RESA, consisting of Mr. Petrie, Mike Latvis, Senior Executive Director of Legislative Affairs and Educational Improvement Consultants Marvin Franklin and Kevin Siefker, participated in the Metro Bureau Annual Golf Outing in July.

President Petrie also shared the following highlights from Wayne County Schools –

- Allen Park –Kudos to incoming Kindergartener, Christian, who read 1,000 Books Before Kindergarten through a free program with the Allen Park Library where children under age five can sign-up and read, read, and read a little more.
- **Hamtramck** Congratulations to Hamtramck Public Schools for pushing girls to consider STEM careers with several female students from Hamtramck Public Schools spending an amazing day at Oakland Airport learning about air physics, aviation, and navigation with a female pilot.
- Livonia Congratulations to Livonia Churchill High School alum James Bolosh on his Tony Award. James thanked Livonia Public Schools on their Facebook page for helping to make his dreams come true.
- Northville Congratulations on a historic year for Northville Mustangs Athletics. They were recently crowned Michigan's Ultimate State Champion. Highlights of the unforgettable year include:
 - State titles in Boys Cross Country and Baseball
 - o Reaching state semifinals in Boys Soccer and Volleyball
 - Top five finishes in Boys Tennis, Gymnastics, Boys Skiing, Boys Swimming, and Boys Track & Field
- Wayne-Westland Kudos to Filip Nowakowski, a recent high school graduate and former William D. Ford Career-Technical Center student, who made an incredible contribution to the center's auto body program. With the help of friends and family, Filip

raised \$2,000 to provide personal protection gear for current students, including ventilators, ear plugs, gloves, safety glasses and masks.

H. Communications – None.

I. Superintendent's Report

Executive Director of Legislative Affairs, Mike Latvis

Mr. Latvis shared the following legislative updates:

- Based on districts' reactions to the budget, there is potential for a supplemental this fall to
 include one-time money for school safety and mental health and a possible per pupil
 increase.
- There may be an agreement from the Governor's Office to sign off on the MPSERS rate reduction of 5.75% ongoing and removing the 3% employee contribution. The Dyslexia bill package is still being discussed.
- There is increasing conversation among legislators regarding health care costs and hard caps.

Deputy Superintendent of Educational Services, Beth Gonzalez

Ms. Gonzalez shared the following updates:

- Per board member request, details were provided for two proposed Superintendent recommendations submitted for board approval.
 - Black Family Development, Inc. (BFDI) will assist and support RESA's School Culture, Climate, & Equity Consultants by providing restorative practices professional learning workshops, coaching, and technical assistance.
 - University of Florida Literacy Institute (UFLI) Essential Background Knowledge Training Program supports the implementation of core reading foundation skills for early grades (K-3). This work supports 25 LEAs, 17 PSAs and 13 non-Wayne County districts.
- RESA is partnering with Michigan Educator Pathway Workforce Initiative (MEWI) on the Pre-K Pathways Project where the first focus will be supporting Child Development Associates (CDA) licensures for people who are interested in working in Pre-K spaces. The Pre-K landscape is dramatically expanding in Wayne County, having 11,000 seats that we are working to fill that requires additional professionals. This partnership will support both teacher certification and director certification. RESA is one of three ISDs in the state partnering with this initiative: Wayne RESA, Montcalm Area ISD and Marquette Alger RESA.
 - O In the last two years, RESA has added five different initiatives to address the teacher pipeline challenge including the Para-to-Teacher program with Wayne State University; Para-to-Teacher program with Eastern Michigan University; Talent Together; the Wayne Teacher Certification Preparation Pilot which focusing on helping teachers pass the MTTC and now the Pre-K Pathways program.

Deputy Superintendent of Administrative Services, Kelly Bohl

Ms. Bohl shared information regarding he proposed action item for the first reading of board policy and administrative regulation updates. Majority of the significant updates include the Title IX changes effective August 1, 2024. Districts are being advised to adopt legal policy to align with the law.

Assistant Superintendent of Financial Services, Drew McMechan

Mr. McMechan addressed several questions from board members and provided clarity regarding the proposed action item for authorization to establish the Wayne RESA Special Education Scholarship Fund. Based on discussion, revisions were made to the clarify board listings.

- The reference to the organization board was changed to the RESA Board who establishes and adopts bylaws, policies and procedures, and approves members of the Fund Board.
- The Scholarship Board was changed to the Fund Board. The majority of Fund Board members must consist of persons who are not directors, officer, employees, insiders or highly compensated independent contractors affiliated with Wayne RESA.

A redline copy of the bylaws and policies and procedures reflective of the updates discussed during the meeting were provided to the Board before taking action on the item.

Superintendent Dr. Daveda Colbert

Dr. Daveda Colbert shared:

- RESA wishes all LEAs and PSAs a safe and impactful school year.
 - O Some teachers returned to their districts this week, starting on Monday, August 19, 2024, and others will return next week, starting on Monday, August 26, 2024. A few school districts will have students return as early as Monday. August 26, 2024, while the majority of the county's students will return the day after Labor Day. The 2024-25 school year is in full effect!
 - Or. Colbert served as the keynote for the LEAP Summit, in partnership with the Good Life Agency, which provided professional development to staff at River Rouge School District for their return to school on Monday, August 19, 2024. The theme was Coaching and Mentoring with a Purpose and Dr. Colbert's keynote shared quotes from Dr. Lisa Delpit, "In order teach you, I must know you." and Simon Sinek's, "Start with WHY," and "People don't buy what you do, they buy why you do it." She followed up with a quote by Dr. Gholdy Muhammad, "Teachers deserve joy." The speech concluded with the motivational video, "The Greatness Within You" featuring Les Brown. It was a powerful day.
- Professional learning opportunities are in high speed at RESA. During the August board meeting, sessions on Restorative Practices and Safe & Legal Support to Students with Health and Medication Needs for PreK-12 educators were taking place on campus.
- Dr. Colbert and Mike Latvis are continuing their summer meetings with superintendents. During these meetings, superintendents provide feedback and share their district's needs.

Members of RESA's leadership team are also taking the opportunity to meet with their colleagues in local districts. Beth Gonzalez and Dr. Jennifer Taiariol are meeting with curriculum leaders and special education directors, Kelly Bohl and Drew McMechan are meeting with finance, operations and HR leaders in local districts, Dana Chicklas is meeting with district's communications teams and Kurt Rheaume is meeting with technology directors.

- Superintendents are inquiring about aviation and aeronautics program and other Career Technical Education opportunities.
- Superintendents have requested support with board training for new members after the November election.
- Superintendents have also provided feedback on services and additional support in specific areas.
- RESA is excited about filling two of the four Early Childhood vacancies with board action during the August meeting and hopes to announce more additions to the department in the upcoming days and weeks.
- The deadline to submit for the Michigan Department of Education's Teacher of the Year award is September 25, 2024. Wayne County has had successful candidates in recent years and are encouraged to submit nominations.
- Dr. Colbert shared that she is excited about the great things happening throughout the
 county, the work RESA is doing internally and to support constituents, and how proud she
 is work alongside the educators in the county, the organization, and the RESA Board of
 Education.
