Regular Meeting November 19, 2025

MINUTES

A. Call to Order

The Regular Meeting of the Wayne County Regional Educational Service Agency Board of Education was called to order by President Mary Blackmon on November 19, 2025, at 8:30 a.m.

B. Roll Call

Member Petrie, with support from Member Funderburg, moved to approve the agenda as presented. On voice vote, motion passed 4-0.

G. President's Remarks and Board Comments

Member Petrie reported positive news regarding board member James Beri who is looking forward to attending the December board meeting. Member Petrie highlighted key takeaways from the MASB Conference, emphasizing mission-focused governance, innovation in education, and the need to develop future problem-solvers. He also commended Drew McMechan for his clear audit presentation at the recent study session and thanked Beth Gonzalez for the comprehensive data review shared with the Board in October.

Member Funderburg reflected on an MASB Conference sessions she attended on a CTE facility design by Kalamazoo RESA that demonstrated strong community voice and a focus on labor-market-aligned programming. She also reflected on Wayne RESA's screening of *Counted Out*, which emphasized culturally responsive instruction and reducing systemic barriers in math

learning. She expressed appreciation for Wayne RESA's leadership in promoting math improvement efforts.

Member Jackson shared insights from a MASB Conference session highlighting Flint's collaborative approach to designing new educational facilities, which intentionally included senior citizens, families, and community members in the planning process. She noted their emphasis on AI readiness, coding instruction, and creating connected educational campuses, as well as creative community engagement strategies used to support bond initiatives.

President Blackmon briefly inquired about opportunities to share the *Counted Out* initiative with county association members for future consideration.

President Blackmon also shared the following highlights from Wayne County Schools –

- Allen Park Congratulations to Jason Skiba, Principal of Allen Park High School, on receiving the 2025 American Association of School Librarians (AASL) Distinguished School Administrator Award.
- Dearborn Congratulations to Smith Middle School's leadership team: Principal Mark Rummel, named Michigan Middle School Principal of the Year, and Assistant Principal Maha Fayad, named Assistant Principal of the Year. Additional recognition was given to STEM Middle School for being named the top middle school in Michigan, and to Howard Elementary, ranked in the top 5% of Michigan elementary schools by U.S. News & World Report.
- Detroit Congratulations to Dixon Educational Learning Academy, whose 21st Century Afterschool Program earned 1st place in a national STEM competition hosted by the Afterschool Alliance.
- Northville Congratulations to Amerman Elementary School for being named a 2025
 Michigan Blue Ribbon School by the Michigan Department of Education—its second
 time achieving this honor.
- **Plymouth-Canton** Congratulations to Gallimore Elementary School, ranked the #1 Elementary School in Michigan by U.S. News & World Report for the third consecutive year.
- Wayne-Westland Congratulations to six students from the William D. Ford Career-Tech Center Cybersecurity Program for earning first place in a national cybersecurity competition hosted by the California Cybersecurity Institute at Cal Poly. The recognized students are Lochlan M., Lillian P., Montrez R., Abdull I., Tyrell P., and Jacob R.
- H. Communications No communications were submitted to the Board.

I. Special Presentations

1. Cognia System of Distinction Award

Michael Nauss, Senior Director for the Cognia Midwest Region, presented Wayne RESA with the Cognia *System of Distinction* Award. He provided an overview of Cognia's history, mission, and global network, noting that only 35 schools and systems worldwide received this distinction in the past year.

Mr. Nauss highlighted that Wayne RESA piloted Cognia's new accreditation standards, becoming the first organization globally to do so, and earned recognition for exemplary

practices in leadership, goal-setting, and reflective accountability. He also noted Wayne RESA's Index of Educational Quality (IEQ) score of 380, significantly above the network average of 296. Mr. Nauss commended Wayne RESA's collaborative leadership team and staff for their exceptional engagement throughout the accreditation process. President Blackmon and board members expressed appreciation to Cognia for the recognition and congratulated Dr. Colbert, the Leadership Team, and RESA staff for their outstanding work and commitment to service.

2. Wayne RESA Audit Report from Plante Moran

Representatives from Plante Moran, including Chris Kassab, Principal and Kristen Grden, Manager, presented the results of the audit of Wayne RESA's financial statements for the fiscal year ending June 30, 2025. RESA received an unmodified (clean) opinion, the highest level of assurance. The auditors reported no findings or questioned costs in the federal single audit of IDEA funds, noting that the final issuance of the single audit report is pending federal release of the compliance supplement. They highlighted the Business Office's strong financial practices, effective internal controls, and consistent compliance despite increasing regulatory complexity.

Board members and Drew McMechan, Assistant Superintendent of Financial Services, expressed their appreciation for the Finance Department and Plante Moran, noting the team's consistent year-round diligence, strong financial systems, and commitment to accuracy and compliance. They highlighted the long-standing record of clean audits, the collaborative partnership with Plante Moran, and the professionalism demonstrated by staff in managing financial requirements and supporting districts across Wayne County.

3. IT Infrastructure Update

Chad Rider, Director of Technology Operations, provided an overview of recent IT infrastructure improvements, district support efforts, and future planning. Key updates included major network upgrades at Wayne RESA, such as increased bandwidth, added redundancy, enhanced VPN security, and cost-saving service transitions, and cybersecurity initiatives, including a statewide tabletop exercise and expanded multi-factor authentication across districts. Mr. Rider also reviewed RESA's current disaster recovery readiness and outlined a five-year plan to move toward an active-active business continuity model with no service downtime. He concluded with a preview of future priorities, including expanded cloud adoption, AI-supported workflows, and continued regional collaboration on technology.

J. Superintendent's Report

Senior Executive Director of Legislative Affairs, Mike Latvis

Mr. Latvis provided an update on state and federal legislative activity, noting limited remaining session days in Lansing and ongoing discussions related to economic development, school safety/mental health funding, and several budget-related sections impacting districts (including 21f virtual days, 164k survey and meal form requirements, and teacher compensation funding). He reported that the deadline for Section 31aa grant opt-in was extended to December 4 and that efforts continue to support districts through potential legislative or supplemental budget fixes. At the federal level, Congress approved a continuing resolution through January 31, and future

impacts on Medicaid eligibility and school-based services remain unclear. Mr. Latvis will continue monitoring developments and advocating on behalf of Wayne County districts.

Deputy Superintendent of Educational Services, Beth Gonzalez

Ms. Gonzalez provided brief updates on several initiatives. She noted ongoing statewide work related to Section 164k and PA 146, explaining that the state-approved literacy curriculum list is not yet published, and no immediate district action is required. She reported continued progress on the countywide aviation and aeronautics initiative, with 177 students currently in exposure courses across three regional consortiums, and strong industry and county executive support for multiple high-wage pathways. Gonzalez also shared that GSRP enrollment stands at 9,850 students (approximately 87% of projected enrollment), slightly below last year's percentage but higher in total students and classrooms. She highlighted the "Counted Out" math film event, including participation from a featured University of Michigan professor and interest from the Wayne County Executive's Office in hosting a future viewing, and summarized Wayne RESA's internal AI pilot (Microsoft Copilot and Google Gemini) focused on efficiency, safety, and accuracy. Finally, she reported that MDE has adopted new state health standards for the first time since 2007, and Wayne RESA's Safe and Healthy Schools team has developed resources to help districts implement them, including processes for reconvening sex education advisory committees and continuing to honor parent opt-out rights for specific content.

Deputy Superintendent of Administrative Services, Kelly Bohl

Ms. Bohl reported that the Michigan Department of Environment, Great Lakes, and Energy (EGLE) now requires a permit as part of the stormwater management program. To meet January application requirements, Wayne RESA must demonstrate adequate regulatory mechanisms beyond existing board policy and administrative guidelines; therefore, a board resolution will be brought forward at the December meeting. She also provided an update on Section 31aa litigation, noting that a court-ordered injunction has delayed the MDE application deadline to while legal concerns regarding the waiver-of-privilege language continue to be reviewed. Additional federal litigation may provide further injunctive relief.

Assistant Superintendent of Financial Services, Drew McMechan

Mr. McMechan reported that the annual financial report is included as an action item, following the auditors' presentation and the November 6 study session review. He highlighted two fund balance updates: the General Fund increased by \$4.7 million, largely due to \$4.8 million in interest income, which is being used for one-time projects, including ongoing improvements and the upcoming Annex construction. He also noted the \$26 million planned spend-down in the Act 18 Fund, primarily for one-time payments to local districts, emphasizing that this was intentional and that the fund still maintains a balance of approximately \$280 million. A recommendation regarding future Act 18 payments will be presented during the development of the FY 2026–27 budget.

Superintendent Dr. Daveda Colbert

Dr. Colbert shared:

As Wayne RESA transitions into the season of gratitude and thankfulness, we pause to
reflect on all that we have accomplished. Our goals and pains, our impact, and the
outcomes that we have achieved together. As we continue to consider our anticipated future
impact and desired results, we also take time to recognize the talents and gifts shared

- individually and collectively across our teams and departments, as evidenced by today's Cognia System of Distinction Award presentation and celebration.
- This has been a heavy year. The state budget pressures, the federal government shutdown that only recently ended and remains uncertain beyond January 31, and the implications for school funding, Head Start, and SNAP benefits all weigh heavily on our communities. With that in mind, we continue to emphasize the importance of intentional self-care. Life and work present real challenges, and even the simplest act of empathy, grace, or kindness can make a profound difference. While our continuous improvement work remains ongoing, it is equally important that we pause to celebrate each gain, each step forward, and every win, large or small. We will continue to build on that momentum together.
- We remain grateful for our Wayne RESA family. Our team is truly outstanding, as affirmed by today's recognition as a System of Distinction by Cognia. Only 35 schools and school systems across the globe are recognized by Cognia for Excellence in Education. Being named one of just seven Systems of Distinction is significant, and even more so, knowing that we are one of only three organizations in Michigan that received Honors of Excellence. We are proud of this distinction and look forward to continued service, leadership, collaboration, and excellence. RESA's commitment to Leading Learning for ALL has been decades in the making, and we honor that legacy.
- Thank you to the Wayne RESA Board of Education, our Finance team, and the entire organization for the consistent work that ensures a clean audit year after year. Every contribution is instrumental to our success, compliance, and financial strength.
- Congratulations to the 2025 Michigan Blue Ribbon Schools in Wayne County, recognized by the Michigan Department of Education for their outstanding academic achievement: Amerman Elementary in Northville Public Schools and Plymouth Scholars Charter Academy in Plymouth. These exceptional schools are among the state's highest performing based on state assessments and nationally normed measures.
- RESA is also proud to congratulate our colleagues and school communities on the voter-approved bonds and ballot initiatives passed on November 4.

- As part of RESA's commitment to being an inclusive organization, we know that it is essential to recognize our veterans and military families. On November 11, we paused to reflect on the bravery, sacrifice, and unwavering commitment of all who have served, recognizing their enduring promise and remembering those who have defended our freedoms with courage and devotion. We are grateful for our colleagues who are veterans and for the families who stand beside them with strength and love. Their commitment inspires us to lead with courage, purpose, and compassion.
- We also pause to remember November 30, 2021, a day of profound tragedy for Oxford High School, the Oxford community, and for all of us throughout Michigan. We honor the memories of Madisyn Baldwin, Tate Myre, Hannah St. Juliana, and Justin Shilling, and we

remember the seven others who were injured. The safety of our students and staff remains our top priority. Resources have been shared with our LEAs, PSAs, and internal teams in support of critical conversations as we approach the four-year anniversary.

- We extend our gratitude to Interim State Superintendent of Public Instruction for Michigan, Dr. Sue Carnell, for her service as she concludes her tenure. We also keep Dr. Glenn Maleyko lifted and encouraged as he steps into the role of State Superintendent on December 8.
- Concerns remain regarding the school safety and mental health funding and the boilerplate language included in the school aid budget. We look forward to clarity from the courts as we remain steadfast in our commitment to school safety and mental health for our students. These funds are critical for districts across Wayne County. We appreciate the statewide efforts that have delayed the final decision to December 4, as the goal is not to impede funding but to ensure the language is constitutional and is clearly understood while making certain schools receive the vital funding in support of school safety and mental health.
- RESA will be closed Thursday, November 27 and Friday, November 28. We will observe
 What I Need Day on Wednesday, November 26, and the organization will reopen Monday,
 December 1, 2025.
- RESA is working to understand the implications of the recently announced reorganization of the U.S. Department of Education. This shift raises important questions about its impact on districts and the continuity of federal support for students. Our priority remains ensuring that every child, in every community, has access to a high-quality public education. We continue to be concerned about responsibilities being divided across multiple departments, as well as the additional burdens placed on states without adequate funding, resources, and support. We will continue to monitor developments and advocate strongly to strengthen public education.
- As always, thank you to the Wayne RESA Board of Education for your unwavering support, advocacy, and governance. We have work to do.
