MINUTES

A. Call to Order

The Regular Meeting of the Wayne County Regional Educational Service Agency Board of Education was called to order by President Mary Blackmon on September 10, 2025, at 8:30 a.m.

B. Roll Call

C. Pledge of Allegiance

D. Approval of Agenda

Member Petrie, with support from Member Jackson, moved to approve the agenda as presented. The motion passed with a voice vote of 4-0.

G. President's Remarks and Board Comments

Member Petrie congratulated Dr. Glenn Maleyko, Superintendent of Dearborn Public Schools, on his appointment as Michigan's next State Superintendent of Public Instruction. Member Petrie noted pride in Wayne County's leadership contributions and welcomed upcoming statewide discussions on education within the political climate, including the gubernatorial race. He also expressed interest in hearing new ideas and collaborating to improve educational outcomes for students across Wayne County.

Member Funderburg thanked Wayne RESA for celebrating her receiving the Michigan Association of School Boards (MASB) President's Award, calling it a humbling experience, and expressing gratitude for the opportunity to support educators and students. She noted that the celebration was made even more meaningful by the presence of her family, including her mother, husband, children, aunt, and friends.

Member Funderburg also highlighted a recent virtual budget discussion with the Wayne County Association of School Boards (WCASB), noting it provided a valuable space for questions and input. Danielle commended Mike Latvis for effectively guiding the session and equipping members with information to engage legislators and their communities.

Member Jackson expressed appreciation for the employee spotlights highlighted by the RESA Social Media Team, noting that she enjoys them and that even her twin grandchildren look forward to seeing the RESA updates.

President Blackmon highlighted the recent all-staff meeting, noting the value of hearing from educators and program leaders, as well as the opportunity to meet new staff members and learn about their interests.

President Blackmon also shared the following highlights from Wayne County Schools –

- **Garden City** - Congratulations to Austin N., who achieved a perfect score of 1440 on the PSAT 9 last spring.
- **Dearborn** – Congratulations to Zahra Makkawi, Student Support Coordinator at Oakman School through Communities In Schools, who was recently honored with the national CIS All In for Students Award.
- **DPSCD** – Congratulations to Pasteur Elementary on the grand opening of its new outdoor classroom. On September 5, 2025, Pasteur alumni, the Friends of Pasteur, donor Ken Eisenberg, and DPSCD celebrated the exciting addition.
- **Ecorse** - Congratulations to Ecorse Public Schools High School Football Coach Larry Johnson, his staff, and the Ecorse High School football team for receiving a \$15,000 grant from the Detroit Lions. The team was presented with the award during a Lions' preseason game.
- **Plymouth-Canton** – Congratulations to the Plymouth-Canton Educational Park community! All three high schools earned top recognition in *U.S. News & World Report's Best High Schools* rankings, placing in Michigan's top 36 and among the top 5% of schools nationwide.

H. Communications – No communications were submitted to the Board.

I. Special Presentations

1. Restorative Practices

Dr. Keisha Allen (CEO, BFDI International Training Institute), Terri Czerwinski (Director of Safe & Healthy Schools), Lisa Kaiser (School Culture, Climate & Equity Consultant), and Dr. Terrance Scott (School Culture, Climate & Equity Consultant) highlighted the philosophy of restorative practices as a relationship and community-building model rather than a disciplinary approach. Since 2016, more than 1,500 educators have been trained across Wayne County, with ongoing efforts to build capacity in schools through professional development and coaching.

2. Take off with Wayne County!

Wayne County Coalition for Future Aviation & Aeronautics Professionals CTE Program and DPSCD's Davis Aerospace Technical High School

Dana Hughes (Executive Director, Detroit Public Schools Community District – DPSCD) and Alycia Merriweather (Deputy Superintendent, DPSCD) outlined current aviation pathways at Davis Aerospace, including AOPA-aligned academics plus three MDE-approved CTE programs in pilot/flight crew, airframe technology/maintenance, and aerospace science & technology. Davis Aerospace will relocate back to Coleman A. Young Municipal Airport in Fall 2026 through an adaptive reuse of the terminal,

with plans to add FAA Part 61 flight school and continued open enrollment.

Beth Gonzalez (Deputy Superintendent of Educational Services) and Krista McKinney-King (Director of Workforce Development, CTE, Adult Ed & Career Counseling) described a countywide coalition creating four regional consortia to expand aviation pathways, beginning with drone coursework in multiple districts and coordinated teacher training, along with exposure programs, e.g., ACE academies, and Aviation Day. Workforce demand data show strong regional and national need for pilots, technicians, and UAS operators. Funding efforts include two pending \$1 million FAA grants and an initial \$25 million advocacy request toward a full buildout via public, corporate, and philanthropic partnerships.

3. Updates in our IT Solutions Consortium

Marilyn Adolph (Director of Application Services), Sandra Dukhie (Executive Director of Student Information Systems and Pupil Accounting), Kurt Rheame (Senior Executive Director of IT Solutions), and Laura Terbrack (Director of Application Development) highlighted major 2024–25 IT Infrastructure improvements.

- SMART (Business Systems) & Transportation – Partnered with district HR/Finance steering committees to deliver 29+ enhancements. Districts were converted to Web Accounts Payable, and for transportation (Polyplot), web migration began with upgraded mapping, deployed Driver Certifications tracking, and enabled mobile Fleet Manager entries.
- MISTAR (Student Information System) – Supporting 37 LEAs, 20 PSAs, and approximately 165 GSRP community sites, MISTAR piloted MTSS and 504 modules, and rolled out Q Analytics dashboards.
- Pupil Accounting – Expanded quarterly/on-demand trainings, issued checklists and newsletters, and launched a Professional Learning Series for new/transitioning pupil accounting specialists.
- Statewide Leadership & Security – RESA Technology Leaders are actively involved in MSBO committees and conferences, serve in advisory roles for the Michigan Data Hub and Great Data Lake, and participate in METL’s MI Secure and MI Cloud initiatives.

J. Superintendent’s Report

Senior Executive Director of Legislative Affairs, Mike Latvis

Mr. Latvis reported state and federal budget/policy updates:

- State Budget –
 - The state budget is still pending, with a potential government shutdown mentioned as a concern.
 - The Senate may act to advance an education plan.
 - Discussions are underway to move all Higher Education funding from the General Fund into the School Aid Fund.
 - There have been inquiries from state contacts about using freed-up MPSERS/OPEB-related dollars for other state purposes over the coming years.
 - An expectation has been communicated that the per-pupil foundation allowance will not be below \$10,000, contingent on final negotiations.
 - If there is a short state shutdown (e.g., beyond Sept 30), MDE could not confirm whether the October 20, 2025 State School Aid payment would be affected; the impact depends on Treasury transfers and programming the final budget.
 - Districts may need to use fund balance, and some may need to borrow

pending October cash flow.

- State Policy Activity –
 - Approximately 140+ bills are being tracked; 12 reported as signed into law.
 - Many measures are characterized as messaging bills; limited movement is expected until the budget is resolved.
 - A student cell-phone use bill is anticipated.
- Federal Budget –
 - There is still no federal budget deal, raising concern about a possible government shutdown and uncertainty around a continuing resolution.
 - The U.S. House proposal cuts Title I, Part A by 25%; the U.S. Senate approach is described as more status quo.
 - Meetings will be held the week of September 15 in Washington, D.C. to quantify a 25% Title I impact on Wayne County districts.
 - A possible federal precision package may include Medicaid changes, and the impact on districts will be monitored.

Deputy Superintendent of Educational Services, Beth Gonzalez

Ms. Gonzalez shared the following updates:

- Talent Together – There are over 300 apprentices statewide in the “grow your own” educator pipeline. An RFP is underway with post-secondary partners to address tuition rates and align cost and quality goals.
- McKinney-Vento Program – RESA hosted a two-day shopping event held for homeless liaisons to collect needed student items (e.g., coats, shoes, laundry supplies). Over 500 coats were distributed.
- Wayne Future Leaders Initiative – The third cohort launched for aspiring assistant principals and principals. It was noted that prior participants are now serving in leadership roles.
- Wayne County Instructional Coaching Network – A countywide kickoff is scheduled the week of September 8, 2025.
- Statewide System of Support (SSOS): On September 11, 2025, RESA will host the annual SSOS Virtual Kickoff Event, “Success Stories: A Kickoff to Transformation.” Several districts will be represented in a panel discussion to share progress, and Romulus Community Schools will highlight system-level improvements linked to M-STEP reading and math gains.

Deputy Superintendent of Administrative Services, Kelly Bohl

Ms. Bohl shared the following updates:

- Wayne RESA was misidentified in litigation related to the juvenile detention facility and Spectrum Health Services; the organization has been voluntarily dismissed from all pending cases.
- A new proposed board policy (first reading) was presented to the board for action during the September meeting documents the existing salary schedule for non-bargaining employees, as recommended by policy counsel.
 - Administrative regulations updated to reflect the relocation of the U.S. Office of Civil Rights services from Cleveland to Colorado.

Assistant Superintendent of Financial Services, Drew McMechan

Mr. McMechan shared the following update:

- Auditors are on site at RESA the week of September 8 as part of the annual financial audit. Follow-up work will continue virtually as financial statements are prepared. The audit presentation to the Board is planned for the November meeting.

Superintendent Dr. Daveda Colbert

Dr. Daveda Colbert shared:

- The month of September marks the return of all scholars, including those who did not have a pre-Labor Day start. We are excited to have every student back in school.
 - Schools have opened smoothly, and great things are already underway. We are very excited about the possibilities for the 2025-26 school year and the ways our scholars will engage, grow and thrive.
 - Thank you to our returning educators and to the new educators who have joined us in Wayne County. Wayne County remains committed to ensuring that zip codes do not dictate destiny.
 - Congratulations to all Wayne County districts on the safe and successful opening of the school year. That is particularly important to acknowledge, as Minnesota experienced tragedy at the opening of its school year. We keep that school community lifted in thought.
 - School safety remains a priority, so that students and staff feel safe and supported, are excited about teaching and learning, and want to come to school and remain a part of the school community.
 - RESA will continue to advocate for school safety funding, safe storage laws, education, and training, and more.
 - Safe storage notifications must be shared with families each school year, and this is an information item as part of our September meeting cadence with Wayne County superintendents.
 - Sadly, when tragedy strikes schools, no matter where in the nation, it impacts us all. We are hopeful for a school year free of incidents like this for the remainder of the calendar.
- The Annual RESA All Staff meeting was held on Friday, September 5, 2025. Thanks are extended to everyone who participated. Each department created videos showcasing their work and contributions.
 - Several hundred “Rays of Sunshine,” anonymous compliments to colleagues, were shared through an automated process created by the Information Technology Solutions team.
 - This innovation reflects Wayne RESA’s commitment to being cutting-edge and forward-thinking, consistently leaning into “Leading Learning for All.”
 - Feedback shows that the All Staff meeting was a memorable event.
 - Thank you to the RESA Board members who attended, and special thanks to Board President Mary Blackmon for her welcome remarks.
 - Thanks are extended to all members of the staff for their contributions in planning the agenda and presenting the identified content throughout the meeting.
- On Tuesday, September 9, Superintendent Dr. Daveda Colbert, Deputy Superintendent Beth Gonzalez, and Assistant Superintendent Drew McMechan participated in the Wayne County

Commissioners' Health and Human Services Committee meeting. They presented as part of the addendum and extension to the intergovernmental agreement supporting three funded projects from the Wayne County Executive's Office in Mathematics, Literacy, and Mental Health. The team answered questions and gave a presentation on how the funding addressed program gaps, expanded mental health supports, and strengthened mathematics coaching and diverse literacy texts in partnership with Newsela. The efforts align with the literacy promise shared at last month's board meeting.

- Thanks to Chair Martha Scott and members of the Wayne County Commission Health and Human Services Committee for the opportunity to participate.
- On Thursday, September 11, RESA will honor the nearly 3,000 people who lost their lives in the 9/11 attacks on the World Trade Center, the Pentagon, and United Flight 93. We also recognize the heroism and resilience of first responders, firefighters, medical personnel, and police officers, who risked and sacrificed their lives to save others. We continue to keep their families lifted in our thoughts.
- Congratulations to Dearborn Public Schools Superintendent, Dr. Glenn Maleyko, who has been selected as Michigan's next Superintendent of Public Instruction. We look forward to the finalization of his contract negotiations and his official start date. Because Dr. Maleyko will not begin on October 4, the retirement date of current State Superintendent Dr. Michael Rice, congratulations are also extended to Interim State Superintendent Dr. Sue Carnell, who was appointed on September 9 to serve during the transition.
 - Dr. Sue Carnell's appointment is historic. She is the first Black woman superintendent for the State of Michigan. A proud Wayne County native from Inkster, Dr. Carnell has held numerous roles in the county: assistant director of special education and principal in Southgate, deputy superintendent in Detroit Public Schools, and superintendent of Westwood Community Schools. She has also served as Education Policy Advisor to Governor Jennifer Granholm and as a Group Executive for former Detroit Mayor Dave Bing. With 40 years of experience in education and government, including her most recent roles as Chief of Staff and Chief Deputy Superintendent at the Michigan Department of Education, she now steps in as Interim State Superintendent.
 - Wayne County celebrates Dr. Carnell's leadership and is proud that both the interim and incoming state superintendents are from Wayne County. Wayne County proud, Wayne County strong!
- State budget delays continue to create uncertainty for Wayne County schools. School Aid Budget delays are causing significant anxiety and operational challenges for districts across the state. By law, districts must adopt a balanced budget by June 30, yet the state budget deadline is July 1. This misalignment creates mixed signals and difficult conditions for planning. With the July 1 deadline long past and no resolution in sight, hopes for an October 1 budget are diminishing. These delays threaten staffing, programming, financial stability, and the execution of plans for this school year. RESA continues to advocate for a more timely and aligned budget process, and equitable funding that meets the unique needs of our scholars and school communities.
- State assessment data has been released, marking an important milestone in our commitment to academic excellence. Preliminary results show Wayne County achieved broad academic gains, with improvements in 15 of the 20 assessments administered this year. Significant strides were made in English Language Arts, Mathematics, Science, and Social Studies, key subject areas that form the foundation of student success. Wayne County students are outpacing statewide

trends, a testament to the dedication of our educators, students, and families. Gains in reading and math are also helping narrow long-standing achievement gaps, reinforcing our focus on equity and excellence.

- While we celebrate this progress, we also recognize the need for continuous improvement across the county. Achieving lasting success requires intentionality and fidelity in implementing multi-tiered systems of support with a particular focus on Tier 1 core instruction and consistent, engaging classroom practices that lead to measurable outcomes. RESA is committed to ensuring that every classroom experience supports student growth and that our instructional strategies are both responsive and evidence based. This includes identifying and addressing areas that require additional support while continuing to build on the strong foundation already in place. As we move forward, we will celebrate the wins, acknowledge the challenges, and remain focused on improved academic outcomes for all Wayne County students.
- Thank you to the Wayne RESA Board of Education for their leadership and unwavering commitment to equity and excellence in Wayne County and also thanks to the amazing Wayne RESA staff for carrying forward the mission and vision of Leading...Learning for All on behalf of the students, families, educators, and communities throughout the county.
